WHEREAS, a Condominium (herein so called) was created pursuant to that certain Condominium Declaration and Condominium Map for Constellation Pointe Dockominiums, a Condominium, recorded on September 7, 2006, under Clerk's File No. 2006061659 of the Official Public Records of Real Property of Galveston County, Texas (as amended, the "Declaration"); and

- 3.1.4 No Owner shall lease a Unit to any person or entity (herein a "Lessee") unless such Owner of the Unit to be leased is also leasing to such Lessee a residence on a Lot which is owned by such Owner."
- 2. Each term used herein as a defined term but not otherwise defined herein shall have the meaning ascribed to such term in the Declaration.
- 3. Except as amended hereby, all other terms and conditions of the Declaration remain in full force and effect and Declarant does hereby ratify and affirm the terms and provisions and covenants thereof except as amended hereby.


